OUR RESIDENTIAL PROGRAMS INCLUDE EMERGENCY SHELTER AND HOUSING ASSISTANCE. EMERGENCY SHELTER SERVICES ARE DESIGNED TO PROVIDE SAFETY AND HELP SURVIVORS AND THEIR CHILDREN GET OUT OF IMMEDIATE CRISIS. IN 2021-2022, BRADLEY ANGLE PROVIDED EMERGENCY SHELTER SERVICES TO 113 TOTAL PARTICIPANTS, SPECIFICALLY 43 ADULT SURVIVORS AND 70 CHILDREN OF THEIR CHILDREN. WE ALSO PROVIDED 6,528 SAFE NIGHTS OF SHELTER. 72.5% OF PARTICIPANTS EXITED FROM SHELTER TO PERMANENT HOUSING.
