OUR RESIDENTIAL PROGRAMS INCLUDE EMERGENCY SHELTER AND HOUSING ASSISTANCE. EMERGENCY SHELTER SERVICES ARE DESIGNED TO PROVIDE SAFETY AND HELP SURVIVORS AND THEIR CHILDREN GET OUT OF IMMEDIATE CRISIS. IN 2022-2023, BRADLEY ANGLE PROVIDED EMERGENCY SHELTER SERVICES TO 73 TOTAL PARTICIPANTS, SPECIFICALLY 26 ADULT SURVIVORS AND 47 CHILDREN OF THEIR CHILDREN. WE ALSO PROVIDED 4,877 SAFE NIGHTS OF SHELTER. 87% OF PARTICIPANTS EXITED FROM SHELTER TO LONG-TERM, NON-TRANSITIONAL HOUSING.
